Discriminant and Predictive Validity Assessment of the Keele STarT MSK Tool for Patients with Musculoskeletal Pain in Outpatient Physical Therapy Settings

This study will investigate the discriminant and predictive validity of a newly developed screening measure (Keele STarT MSK tool). Discriminant validity of the Keele STarT MSK tool will be assessed for intake pain (pain intensity, pain interference), physical health, mental health, psychological factors, comorbidity, and region-specific disability across common MSK pain conditions (i.e., neck, low back, upper extremity, lower extremity, or multiregional pain). Predictive validity of the new tool will be assessed for pain intensity, physical health, mental health, and region-specific disability outcome measure scores at 8 weeks and 6 months.
