Session Title: Introduction to systematic reviews

Audience: Any HSC faculty, staff, or student

Taught: Since 2013

<u>Description</u>: This one-hour session introduces learners to systematic reviews, distinguishes between various types of reviews (e.g. literature reviews, scoping reviews, systematic reviews, and meta-analyses), describes various guidelines for conducting systematic reviews, and briefly introduces the process of conducting a systematic review. Concepts presented include: term harvesting, snowballing, and grey literature. The session is intended as an introduction to the complexities and challenges of successfully conducting a high-quality systematic literature review.

<u>Session Title:</u> Medical Terminology <u>Audience:</u> Any HSC faculty, staff, or student Taught: 2013-2018

Description: This workshop consists of three two-hour sessions that cover the basics of medical terminology. Key concepts in the first session include word building, as well as the basics of body structure, including cells, tissues, organs, and body planes. Session two presents a review of body systems including integumentary, musculoskeletal, circulatory, lymphatic, nervous, sensory, reproductive, and urinary systems. Session three concludes the review of body systems with respiratory, digestive, and endocrine systems and covers diseases, diagnosis and treatment words. Lab tests, imaging, drugs, and surgery are included. The workshop is intended to introduce non-clinicians to medical terminology in the context of body systems and common pathologies and diagnostic tests.

A team of librarians with liaison responsibilities for the medical student classes, Hannah Norton, Nina Stoyan-Rosenzweig, Ariel Pomputius, and I created a series of videos on evidence-based medicine literature searching for medical students. Additionally, the liaison librarians observed a marked increase in the pre-requisite knowledge and skills of first year medical students in the evidenced-based medicine course.
