2017-present Faculty Mentor for Female Residents in Internal Medicine Interest Group (FRIM). I worked with the internal medicine residents to form this interest group in August of 2017. As faculty mentor, I work with the residents in the group to identify topics for monthly meetings focused on issues related to female residents. I coordinate recruitment of faculty guest speakers, facilitate discussions and peer to peer mentoring. Monthly meeting formats include didactics, role playing sessions, journal clubs.

2015-present High Value Care Curriculum implemented in Internal Medicine Residency Program. Embedded in the Ambulatory rotation, residents are exposed to a two-part high value care curriculum. The first part includes ½ day didactics delivered by faculty members focused on high value care

principles of clinical medicine. The second part includes one morning report per month where residents work through cases and attempt to ensure appropriate medical management and diagnosis while competing to complete the case for the lowest cost. Costs of medical care are analyzed and explained to the residents in these sessions. Implemented in 2015, this curriculum continues to challenge the residents and improve their understanding of medical economics.
