BRIEF DESCRIPTION OF CURRENT JOB DUTIES

A. Clinical Teaching

Currently, my primary duties include clinical supervision and training. I serve as an attending neuropsychologist within UF Health Psychology Specialties with a weekly outpatient clinic at The Fixel Institute for Neurological Disorders. My primary role is to train and supervise predoctoral students, interns, and postdoctoral fellows in the neuropsychological assessments of older adults. I do so within a cultural neuropsychology framework. Patients seen are typically referred for differential diagnosis of MCI and dementia (e.g., Alzheimer's dementia, Lewy Body dementias, Frontotemporal Dementia, Vascular Dementia, etc.). Other patient types include those with psychiatric disorders, stroke, movement disorders, TBI, and epilepsy. I also supervise short-term cognitive rehabilitation therapies (EON-MEM; HABIT™) as well as psychological treatment of older adults with mood disturbances.

B. Research

I am a research mentor for undergraduate, graduate students and postdoctoral fellows in the Brain Health Equity and Dementia Prevention Lab, while also serving on master's and dissertation committees for other students within the Neuropsychology Division. My research program focuses on studying cognitive changes in older adults with MCI and neurodegenerative disorders (i.e., Alzheimer's disease and related disorders). Broadly, I am motivated to better understand the health, psychosocial disparities, and resiliency factors that influence the onset, diagnosis, and treatment of

these disorders in minoritized populations. Prior work has focused on examining behavioral/lifestyle interventions for mild cognitive impairment (MCI) that will improve functional outcomes in individuals at risk for progression to dementia. I also aim to elucidate barriers to participation in behavioral intervention research for MCI amongst underrepresented minority communities. My most recent study examines cognitive and psychosocial factors that affect medical and behavioral treatment adherence in older adults with metabolic syndrome at risk for dementia. I have received funding from federal and non-profit organizations to support this work. My goal is to apply this research to promote health equity and advance tailored behavioral interventions that mitigate functional decline and promote cognitive health in these populations.

C. Service

I serve the local community by providing free monthly neurocognitive screenings for underserved and underinsured individuals (Neurocognitive Screening Initiative) as the lead neuropsychologist with a team of graduate students and postdoctoral trainees in collaboration with HealthStreet, a community engagement program at the University of Florida. *I, along with the student team, have established this service through ongoing community outreach efforts and forging relationships with other local community organizations.*
